Newborn Hearing Screening Test Subsidy

Mother and Child Health Subsection, Health Promotion Section **25984-4621**

You will receive a newborn hearing screening test slip (for one test). Part of the cost is covered by public funds. The slip can be used at contracted medical institutions in Tokyo and at some contracted medical institutions in Saitama Prefecture. The screening test will include the checkup items and methods listed on the slip. If the cost exceeds the maximum amount of public funds, you will have to pay the difference out of pocket. The cost is set by each medical institution; please check during your visit.

Expectant Mother Health Checkup and Newborn Hearing Screening Test Subsidies for Mothers Giving Birth in Their Hometown

Those who receive expectant mother health checkups or a newborn hearing screening test at a midwifery or medical institution outside of the metropolitan Tokyo area and are unable to use their health checkup slips can receive subsidies to cover a portion of the costs (within the limit of public funds). Please read the handout on Nerima City subsidies provided to mothers giving birth in their hometown for expectant mother health checkups and the newborn hearing screening test, which accompanies the Mother and Child Health Handbook, or read the Nerima City website.

Childbirth and Childrearing Lump-Sum Benefit

As a rule, the childbirth and childrearing lump-sum benefit is ¥420,000. This sum is paid to the medical institution where the birth occurred from the health insurance (such as National Health Insurance or a health insurance union) the mother is enrolled in. (Note: There are direct payment and proxy receipt systems.) Therefore, as a rule, the amount you pay to the medical institution is the total childbirth expense minus ¥420,000. Please check with the medical institution you intend to use

about whether you can use the direct payment or the proxy receipt program. If you cannot or do not use both systems, please ask the health insurance plan in which you are enrolled to help. If you are enrolled in health insurance through your company, please ask your place of employment or your health insurance union.

If an expectant mother needs to be hospitalized for a health-related reason but is in financial difficulties, she can give birth at a designated hospital or maternity center free of charge or at low expense. This is a program provided through the Child Welfare Act. There are income-based restrictions, and an application is required before birth. In addition, the expense not subsidized is determined by the household's eligibility status.

When an expectant mother or infant from a household that receives public financial assistance for everyday living or is exempt from resident's tax undergoes a health checkup/test at a designated medical institution and presents one of these health instruction slips, the cost can be subsidized. (Please consult your local Public Health Center branch in advance.)

* These slips cannot be used together with the health checkup slips for expectant mothers and the newborn hearing screening test slip.

Expectant mothers and infants from a Eligibility household that receives public financial assistance for everyday living or is exempt from resident's tax.

Medical Subsidies for High Blood Pressure Syndrome Related to Pregnancy, Etc.

Mother and Child Health Subsection, Health Promotion Section ☎5984-4621

Residents who require hospitalization for pregnancyinduced high blood pressure syndrome, diabetes, anemia, obstetrical bleeding, heart disease or other diseases-as well as secondary diseases or symptoms related to the primary disease-can receive subsidies to cover the personally borne costs of treatment. However, the household income earned during the previous year must be ¥30,000 or less, or the estimated hospitalization must be for 26 days or longer.

* You must apply within three months from the day you leave the hospital.

Special Subsidy for the Costs of Fertility Treatment

Mother and Child Health Subsection, Health Promotion Section **☎**5984-4621

Nerima City offers a partial subsidy for those approved for the Tokyo Metropolitan Government's special subsidy program for fertility treatment*. The subsidy has a ceiling. Please call for more information.

* This applies to treatments such as in-vitro fertilization, micro-insemination and the testicular sperm extraction (TESE) method.

Subsidies for the Costs of Rubella Antibody **Tests and Rubella Vaccinations**

Prevention Subsection, Public Health and Disease Prevention Section, Nerima Public Health Center

Infection with rubella virus in the early stages of pregnancy can result in the birth of a baby with congenital rubella syndrome. For this reason, full subsidies are provided for the cost of antibody tests for those who wish to become pregnant, and full subsidies for the cost of rubella vaccinations for those who have low levels of antibodies or no antibodies to rubella virus.

Eligibility

Women who wish to become pregnant, members of the same household as women who are pregnant or wish to become pregnant

- * Those who have already received the rubella or MR (measles-rubella combination) vaccinations using the Nerima City optional subsidy program are not eligible.
- * Women who are found to have low levels of antibodies during an antibody test during pregnancy (health checkups for expectant mothers) are eligible for the vaccination subsidy. Please note that you cannot receive the vaccination while pregnant.

Exemption from National Pension Premiums During the Period Before and After Birth

National Pension Subsection, NHI & National Pension Section **☎**5984-4561

National Pension premiums for the period of four months from the month prior to the expected date of birth or the month in which the birth takes place (in the case of multiple birth, the period of six months from three months prior to the expected date of birth or the month in which the birth takes place) are exempted upon notification. Please apply on the child's date of birth, or within fifteen days after the planned move date you reported to the municipality administering your previous address. Public servants should apply at their place of employment.

Between three years of age and the sixth grade of elementary school:

¥10,000 for the first or second child; ¥15,000 for the third or subsequent child

Junior high school student: ¥10,000 If your household income exceeds the income restriction: ¥5,000

Benefit for the Birth of a Third Child

Parents/guardians who meet the requirements below will receive a financial gift if they have a third or subsequent child. (There are no income restrictions.)

- The parents/guardian are living with and raising three or more children, including the third or subsequent child (until the first March 31 after a child reaches eighteen years of age).
- The family has completed resident registration in Nerima City one year before the date of birth (or the due date) of

- the third or subsequent child. (Foreign residents must also have a proper visa.) If it has been less than one year, the application can be made once one year has passed from the date resident registration is completed in Nerima City.
- The parents/guardian intend to continue residing in Nerima City with their children for one year or longer after receiving the financial gift.
- * The application period is one year from the date of birth of your third or subsequent child.

Benefit amount

¥100,000 per child for your third child and subsequent children. (¥200,000 per child born on or before March 31, 2021)

Medical Subsidies for Children (Maru-Nyu/Maru-Ko Medical Certificates for Infants and Toddlers/Children)

Preschool children receive Maru-Nyu medical certificates, and children in elementary or junior high school receive Maru-Ko medical certificates, respectively. When you have one of these certificates for your child, Nerima City offer subsidies for the personally borne expense when your child received health insurance-covered treatment, and the standard personally borne expense for meals during hospitalization. No income restrictions apply.

* If a child moves to Nerima City, the City Office will send you application form.

Subsidy for Periodic Immunization Costs Due to Giving Birth in One's Hometown

Prevention Subsection, Health and Prevention Section, Nerima Public Health Center

This subsidy is provided to those who, due to unavoidable circumstances such as giving birth in one's hometown, have been vaccinated at medical institutions other than the cooperating medical institutions that provide immunizations in the 23 cities of Tokyo, Nishitokyo City (excluding BCG) and Musashino City, and have paid the periodic immunization costs out of pocket.

* In order to receive the subsidy, there are certain procedures that need to be completed before you receive the vaccination. For details, please see the Nerima City website or contact the Prevention Subsection, Public Health and Disease Prevention Section.

Medical Benefits for Premature Babies

Mother and Child Health Subsection, Health Promotion Section

If a child's perinatal weight is 2,000 g or less, or if the child is particularly weak and is hospitalized in a designated medical institution, this benefit is provided to cover personally-borne expenses incurred after health insurance coverage.

Eligibility

A child whose perinatal weight is under 2,000 g, or is particularly weak and is hospitalized in a designated medical institution

Medical Subsidies for Special Chronic Pediatric Diseases

Prevention Subsection, Health and Prevention Section, Nerima Public Health Center

25984-2484

Based on the Japanese government's special chronic pediatric disease support program, which aims to use information on the treatment of designated diseases for future research. The subsidy will cover part of the cost of treating designated diseases covered by health insurance.

* Only treatment covered by health insurance can be subsidized.

Eligibility

- Those under eighteen years of age living in the metropolitan Tokyo area
- Those being treated for a special chronic pediatric disease that the subsidy covers, and who meet separately designated approval standard

Pediatric Mental Illness Medical Expense Subsidy Program

Mental Health Subsection, Public Health and Disease Prevention Section, Nerima City

When a child requires inpatient treatment for pediatric mental illness, this program subsidizes the out-of-pocket hospitalization expenses that are covered by health insurance, excluding the cost of meals, after the High-Cost Medical Expense Benefit has been received (private room charges and other costs not covered by insurance are exempt).

Eligibility

Those to whom all of the following apply:

 Individual under 18 years of age who is hospitalized in a psychiatric hospital or psychiatric unit bed (Those who apply by two days before their 18th birthday are eligible.)

- 2. Individual who is a registered resident of Nerima City
- 3. Individual who is enrolled in health insurance

Medical Subsidy for Services and Support for Persons with Disabilities (childrearing-related medical treatment)

Prevention Subsection, Health and Prevention Section, Nerima Public Health Center

☎5984-2484

When a child with a physical disability receives treatment to improve his/her capacity to lead a regular life at a designated medical institution that offers services and support for persons with disabilities, part of the cost of medical treatment is subsidized.

* Only treatment covered by health insurance can be subsidized.

Eligibility

- Children under eighteen years of age with a physical disability with a strong chance of being cured through surgery and/or other treatment
- Those undergoing medical treatment at a designated medical institution that offers services and support for persons with disabilities (childrearing-related medical treatment)
- 3. The parent/guardian is a registered resident of Nerima City
- 4. The municipal resident's tax of the household is under ¥235,000*
- * If the municipal resident's tax of the household is ¥235,000 or more, in principle, the child is not eligible for this subsidy; however, they may be eligible if certain conditions are met. For details, please contact the Prevention Subsection, Public Health and Disease Prevention Section.

Medical Childrearing Benefits

Infectious Disease Control Subsection, Public Health and Disease Prevention Section, Nerima Public Health Center

These benefits are provided to parents/guardians of children under eighteen years of age needing longterm hospitalization due to tuberculosis, and cover the personally borne expenses for various insurancecovered medical treatment. The benefits also include necessary supplies for schooling and living at the hospital. (The personally borne expenses depend on the family's income.)

Eligibility

- 1. The child is hospitalized at a designated medical childrearing institution
- The recipient also receives medical treatment benefits for tuberculosis according to the Infectious Diseases Control Law. (You can apply for both benefits at the same time.)

- 2. Handbook for the Physically Disabled, levels 1 or 3
- 3. Those with cerebral palsy or progressive muscular atrophy
