① Household whose members are all exempt from per capita resident tax for [Fiscal Year\(FY\) 2025](#)

② Household which has received the child rearing allowance in [January 2026](#)(for [November 2025](#)) from Nerima City.

③ Household with sudden change in family finance in [2025](#) and was recognized to be in the same situation as ①.





● About the documents A, B.

A [In principle, no action needed.](#)

※ Nerima City might send you the document to [confirm](#) your eligibility on condition that you have not filed the resident tax return or of the timing when the household consisting members changed.

► Nerima City starts to send the payment notice from [late January](#).

[You are required to submit the document if you would like to change the bank account for receiving the benefits or reject to receive the benefits.](#)

Benefits payment is to start from [late February](#) unless the household has submitted the document.

※ Please check the information written on the back side for further information on the eligible households [②], [③] and the document B.

B Action needed

► Nerima City starts to send the document to [confirm](#) your eligibility ("confirmation letter") from [late January](#).

After checking the enclosed document, please send the required documents back to Nerima City.

※In case you would not like to receive the benefits, you do not need to send them back.

It takes at least [4 weeks](#) after Nerima City receives the document until the benefits are [transferred](#).

Eligible households② Household received the dependent child allowance in [January 2026](#)(for November 2025).

Principally no action needed.

► Nerima City starts to send the payment notice from [late January](#).

※You are required to submit the document if you would like to change the bank account for receiving the benefits or reject to receive the benefits.

Benefits payment is to start from [late February](#) unless the household has submitted the document.

Eligible households③ Household with sudden change in financial situation (Need to apply)

Household where all members' income level has dropped to the same level as being exempted from resident tax due to unexpected sudden financial change in and after January 2025

► After filling out the application document, send it back to Nerima City by post together with other required documents.
